6. **A statement, under penalty of perjury, that:**
 - You are the copyright owner or authorized to act on behalf of the copyright owner
 - The information in your notice is accurate
 - You understand that you may be liable for damages (including costs and attorneys' fees) if you materially misrepresent that material is infringing
7. **Your physical or electronic signature**

Response to DMCA Notices

Upon receipt of a compliant DMCA notice, the Company will:

3. Provide the uploader with an opportunity to submit a counter-notification
4. Restore the material if a valid counter-notification is received (unless the copyright owner initiates legal action)

Counter-Notification

If you are the creator of allegedly infringing Content and believe the takedown notice is in error or misapplied, you may submit a counter-notification, which must include:

1. **Your identification** (name, address, phone number, email)
2. **Identification of the material** that was removed and the location where it previously appeared
3. **A statement, under penalty of perjury**, that you have a good faith belief that the material was removed due to mistake or misidentification
4. **Your contact information**
5. **A statement that you consent to jurisdiction** of federal court and service of process by the person who submitted the original notice
6. **Your signature**
